In the end, the jury believe the defence lawyers and decide that Darnay is not guilty, which means that Barsad is probably a spy.
- 3 Charles Darnay, the prisoner, and Sydney Carton, a defence lawyer, look very alike.

 This is important because it means that the witness cannot be certain that the man he saw near the army building was Darnay. Perhaps it was someone else who looked like him.

CHAPTER FOUR

- 1 *Example answer*: Someone throws the coin back because they are angry with the Marquis for thinking that money is the answer to killing someone's child. It could be Madame Defarge, who is staring at him, or one of the people in the crowd.
- **2** He says that he would wipe them from the face of the Earth, which means that he wants to destroy them, probably by killing them violently.
- **3** Gaspard is hiding under the Marquis's carriage. He is following the Marquis to his home in the country and he is probably planning to kill him.

CHAPTER FIVE

- 1 Darnay loves Lucie and wants to marry her. At the time, it was normal for a man to ask a woman's father to agree to their marriage first. In this case, Darnay also wants to tell Doctor Manette that he understands how important Lucie is to him. Darnay promises that he will not take Lucie away and that, if they get married, he will live in the Doctor's house with them.
- **2** He should tell him his real name, which is Charles Evrémonde.
- **3** He says this because he loves her and he would prove this by doing anything for her. He would even die to save someone she loves.

CHAPTER SIX

1 The King and Queen have a palace at Versailles and people go there to see them because they respect them. But Defarge and his wife think that seeing them will make the road-mender want to fight against them more.

- 2 He talks about the poor and oppressed people of Saint Antoine and how they feel because he wants to trick Madame Defarge into telling him her true opinions. He hopes that she will share some information about the Marquis's murder with him.
- 3 He calls him Jacques because that is the name that many men used during the time of the Revolution to show that they were part of it. Barsad is telling Defarge that he knows he agrees with the Revolution. He wants Defarge to think that he does, too.

CHAPTER SEVEN

- 1 As promised, Darnay is telling Doctor Manette his real name, which is Charles Evrémonde.
- **2** He begins to make shoes again because he is very upset by what Darnay has told him. His memories of being in prison are recalled and he becomes ill again.
- **3** She defends Carton because, from her conversation with him in Chapter Five, she knows that he is a better man than Darnay thinks.

CHAPTER EIGHT

- 1 *Example answer*: He searches it because that is the cell that Doctor Manette was locked up in. He thinks that he might find something useful there.
- **2** Example answer: He probably tells them that the château of the Marquis of Evrémonde is going to be burned that evening.
- **3** They want to attack Monsieur Gabelle because he was responsible for collecting their taxes and their rent.

CHAPTER NINE

- 1 They meet at Tellson's Bank, where Mr Lorry works.

- 3 Doctor Manette saves him. He tells the court that Darnay is his good friend and his daughter's husband. He also tells them about Darnay's trial in England, when Darnay was thought to be an enemy of the aristocrat English government. The French people trust Doctor Manette because he was once a prisoner of the Bastille.

CHAPTER TWELVE

- 1 She meets her brother, Solomon Pross. His other name is John Barsad. He is in Paris because he is a spy for both the French and English governments.
- **2** Mr Lorry is surprised to see Barsad.
- **3** He asks Barsad to let him visit Darnay in prison because Barsad sometimes works as a jailer there.

CHAPTER THIRTEEN

- 1 Her younger sister is still alive.

- 1 *Example answer*: He feels responsible for the jury's decision because he denounced everyone in the Evrémonde family many years ago. He feels guilty and very upset that Darnay will be sent to the Guillotine because of what he wrote in prison a long time ago.
- 2 She hates them because it was her family who were treated so cruelly by the Evrémonde brothers she was the younger sister who was hidden to keep her safe.
- **3** They are in danger because Madame Defarge may denounce them for making signs to prisoners from the street. She hates everyone connected with the Evrémonde family and wants them all dead.

CHAPTER FIFTEEN

- 1 Carton has some packets inside his shirt that he bought from the chemist's the day before. He knows that if these things are mixed together they will make someone unconscious. He hides them from Darnay and puts them close to his face so that he breathes them in.
- 2 Carton does not want Darnay to notice what he is doing. Writing the letter keeps Darnay busy while Carton is making him unconscious. The letter is for Lucie and it explains that Carton is giving up his life to save the life of someone she loves. He told her in Chapter Five that he would be prepared to do this.
- **3** Sydney Carton, Miss Pross and Jerry Cruncher are not travelling in Mr Lorry's carriage.

CHAPTER SIXTEEN

- 1 Defarge was Doctor Manette's servant when he was a young man. He knew Doctor Manette before he was sent to the Bastille and he knew that he had done nothing wrong.
- **2** She cannot hear anything because the gun has made a very loud noise and damaged her hearing for ever.
- 3 She thinks he has been sent to her by Heaven because he is so good to her. He comforts her and keeps her calm in the terrifying moments before her death.

After-reading questions

- 1 Example answer: He is going to tell Lucie, Doctor Manette and Mr Lorry what Carton did in the prison. At some point he going to find the letter that Carton made him write in his pocket. He will show it to Lucie, who will understand it because she will remember the conversation she had with Carton in Chapter Five.
- **2** *Example answer*: It is written in the present tense. It shows what is happening in the present moment, which makes the writing immediate and adds drama. It leads up to the ending of the story, which is about what will happen in the future.
- 3 Example answer: Carton does not consider his own life to be valuable. He has a problem with drinking too much wine and cannot stop. He says that he does not care for anyone in the world and no one cares for him. He thinks that he is worthless and not capable of doing any good. However, he loves Lucie and is ready to prove this by giving up his life to save her husband's life.
- 4 Ernest Defarge agrees with the Revolution against aristocrats but he has not suffered cruel treatment from any of them like his wife has. He also knew Doctor Manette a long time ago and knew that he was a good man. He liked him and knew that he had not done anything wrong when he was thrown into prison. The Evrémonde brothers were responsible for the death of Madame Defarge's father, brother and sister, and she will never forgive them or anyone in the Evrémonde family. She believes that they must all be punished for what the brothers did and that she has the right to kill them.
